RE: 2010 Election

The Latah County Library District invites registered Latah County voters who share an interest in their public library to submit a Declaration of Candidacy for one of the two positions that will open on the district's board of trustees. Both positions will be for terms expiring in 2015. The board of five trustees meets on a monthly basis, generally on the third Tuesday of the month; the board has the legal responsibility to provide library services in the district and works closely with the district director to provide excellent public library services throughout Latah County.

The countywide election for these positions will be Tuesday, May 25, 2010. Inclusion on the ballot requires that the Declaration of Candidacy, obtainable from the County Clerk, from any District Library, or from the district's web site at [www.latahlibrary.org](http://www.latahlibrary.org), and signed by at least five (5) qualified electors, be submitted to the County Auditor, at the Latah County Courthouse in Moscow, for verification of signatures. The verified Declaration is then to be copied and the original filed with the Latah County Library District Director at the Moscow Public Library, 110 South Jefferson, prior to 5 p.m. on Friday, March 19, 2010.

A complete trustee candidate information packet is available at any of the seven district libraries during normal business hours. The candidate packet is also available on the district's website. The deadline to submit a write-in candidacy form for this election is 5 p.m. Friday, April 30, 2010.

Please note: There are two positions up for election this year. One position is for a full 5-year term expiring in 2015. The incumbent is retiring from this position and the seat is open. The other position is for a seat that was filled by appointment after no one filed to run for it in 2009. The Board appointed Mary McGregor of Moscow to fill this seat and she has indicated that she intends to run for the remainder of the term. This would normally be a 4-year term but because of a provision in the election reform law which the legislature passed last year it will not expire until 2015.
